## SECURITY DEPARTMENT

### CAMPUS SAFETY AND SECURITY

All crimes or suspicious incidents should be reported to the Security Department immediately (The campus emergency number is 1111. The emergency number from Sophie Fricke or G.S.R. is 327-7111. Routine calls to Security should be made on 8506). The Security Department will respond to all reported incidents and in appropriate instances notify the New York City Police Department. All crimes and serious incidents will be investigated by a security supervisor in addition to any police action taken.

All visitors to the campus must be registered by the security officer at the gate and announced to their host.

The Security Department is staffed with 39 personnel. A minimum of seven (7) security supervisors and officers are assigned on each of the three shifts. During non-business hours the Security Department routinely patrols all of the buildings on campus. The patrols average one complete patrol every four hours.

The following information is being made available in accordance with recent changes to the Student Right-to-Know and Campus Security Act of 1990 and the N.Y.S. Education Law.

#### 2. REQUIRED SECURITY INFORMATION

- There are 39 security personnel assigned to the Security Department.
- There are 226 students residing on campus.
- The average number of students per security campus officer on each shift is 28.
- Security Campus Officers are stationed at the gates of the university, not at the individual dorms.
- Non-resident guests are required to register their presence either at the Housing Office or Security Department.
- Non-resident guests **must** be accompanied by a student.
- Prior to being assigned to security duties all security personnel receive sixteen (16) hours of classroom instruction and one hundred twenty hours (120) of field training with a supervisor. All security campus officers receive an additional eight (8) hours of in-service training annually as well as roll call training on a daily basis. There are six part-time officers. No

students are utilized as security officers. Security Campus Officers are screened through normal Personnel Department screening procedures. 39 guards are registered with the N.Y.S.D.C.J.S. according to the Security Act of 1994.

- h. The entire campus is patrolled during non-business hours. Patrols are conducted on the hallways and public areas of student dorms every four hours.
- i. The Graduate Students Residence Hall (GSRH) and Sophie Fricke Hall (SFH) Buildings have nine (9) of their entrance doors controlled by a card key access system. The card access doors are also alarmed.
- j. The unlawful possession, use or distribution of illicit drugs by students and employees on University property is a violation of University rules as well as New York State Law.
- k. Persons under the age of twenty-one are not permitted to consume alcoholic beverages on campus or at campus sponsored functions.
- l. Students desiring a change in roommates can do so by notifying the Housing office. The change can be made immediately in those instances caused by the roommate's use of drugs or other misconduct.
- m. The emergency telephone from the students dorms is 327-7111. This number is conspicuously posted in the dorms.
- n. Alleged sex offenses by students against other students that are criminal in nature will be investigated by the Security Department and referred to the New York City Police Department.

### **3. INFORMATION REGARDING PERSONAL SAFETY AND CRIME PREVENTION**

Students are advised and updated concerning security matters by the following:

- a. The Security Department maintains close liaison with the Student's Representative Council, informing and advising them on security related issues and developments.
- b. The University newsletter is utilized to inform the campus community of current security developments and concerns.
- c. Special security bulletins are issued as needed.
- d. Security pamphlets that deal with various personal safety concerns are available in the Security Department office. These pamphlets are published by the New York City Police Department.
